Look for FARM TOUR signs along the route!

Directions From Extension Center to Stop #1:

South on S. Bickett Blvd./ US-401 towards Raleigh. At "Harris X-roads", turn **right** onto **Tarboro Road**; travel 2.2 miles and turn **left** onto **Moore's Pond Road**; Hidden Pond Farm is on the **left** (0.3 miles).

Directions From Stop #1 to Stop #2:

Leaving Hidden Pond Farm, turn **left** onto **Moore's Pond Road**, travel 1.7 miles and turn **right** onto **Satterwhite Road** which becomes **Jack Jones Road**; be careful.. you will need to **cross** NC Hwy. 96 and continue on **Jack Jones Road**; At the stopsign, turn **right** onto **Averette Road** (in Wake County now); Matrix Farms is on the **left**.

Directions From Stop #2 to Stop #3:

Leaving Matrix Farms, turn **left** onto **Averette Road** for 1 mile; turn **right** onto **Oak Grove Church Road**; At the 2nd left, turn **left** onto **NC Hwy. 96**, traveling until you get to the stoplight on **Main Street** in **Youngsville**; at the Stop light, turn **right** onto **E. Main Street** for 0.6 miles; Turn **slight left** onto **Cedar Creek Road** and travel 0.9 miles; Take the 1st **left** onto **Hicks Road** and travel 3.3 miles; Ingleside Farm is on the **left**.

Directions From Stop #3 to Lunch, Extension Center:

Leaving Ingleside Farm, turn **left** on **Hicks Road** for 0.5 miles; Turn **right** onto **Cedar Creek Road** for 1.7 miles until you turn **left** onto **Lane Store Road**; Traveling 2.3 miles, turn **right** onto **NC 56 Hwy** towards **Louisburg**; Turn **left** onto **S. Bickett Blvd/US 401 N/NC 56 East**; travel 1.6 miles crossing the **Tar River**; Extension Center is on the **right** (behind car wash) on the hill... right before the 2nd stoplight (intersection of 56 E and Bickett); **Annex** is in the back of the building .. follow the cement walkway.
